REGULATIONS OF THE MORAVIAN SQUARE MARKET

The purpose of the Moravian Square Market is to provide a farmers market for the community and support local ministries for the hungry.

- 1. Persons wanting to sell at the Moravian Square Market must submit an application before they plan to begin selling. Applications are available at the Rural Hall Moravian Church website (www.rhmc.org/market). The fee to participate in the Moravian Square Market is \$5 per week or \$100 for the season. All vendor fees will be donated to a local food ministry at the end of the season.
- 2. Baked goods must be made in an inspected kitchen. Vendors must provide a copy of their meat license prior to selling meat.
- 3. The Market Committee has the right to terminate a vendor's contract for any reason.
- 4. Vendors may authorize family members or employees to represent them at the Market as long as the family member(s) or employee(s) are listed as a proxy on the Moravian Square Market application form.
- 5. The Moravian Square Market will operate on the grounds of Rural Hall Moravian Church, **7939 Broad Street, Rural Hall, NC** (in the side gravel lot). In the event of rain, the market can be moved to the Pavilion at Rural Hall Moravian Church. The Moravian Square Market will operate on **Thursdays from 2:30 pm-6:00 pm**. The selling season will begin April/May and go through the end of September/October depending on fall frost and customer traffic.
- 6. Products that can be sold at the Market include:
 - a. Vegetables
 - b. Fruits, nuts, or berries
 - c. Plants
 - d. Eggs
 - e. Cheese
 - f. Honey
 - g. Flowers

- h. Firewood
- i. Meats
- j. Baked goods all items must have ingredients listed
- k. Crafts all crafts must be handmade items that require skill and time to fashion

Other Requirements:

- 1. No animals will be sold, traded, or given away at the Moravian Square Market.
- 2. Each vendor is responsible for cleaning up the area around their space at the Market.
- 3. Vendors should not move their vehicles in or out of the Market during the hours of operation.
- 4. Prices are to be posted on all items offered for sale.
- 5. Selling spaces are on a first come first serve basis; there are no assigned or reserved spaces.
- 6. We offer no promise of exclusivity in regards to items sold. Multiple vendors might sell the same or similar products or produce.
- 7. Special needs requests are to be expressed in advance.
- 8. All participants of the Moravian Square Market are expected to be courteous, professional, and ethical in all transactions. All participants are to abide by the rules and regulations of the Moravian Square Market. This includes and is not limited to, no profanity, no tobacco products, no consumption of alcoholic beverages or any other disruptive behavior. The Moravian Square Market does reserve the right to ask a vendor to leave the premises due to any improper conduct.
